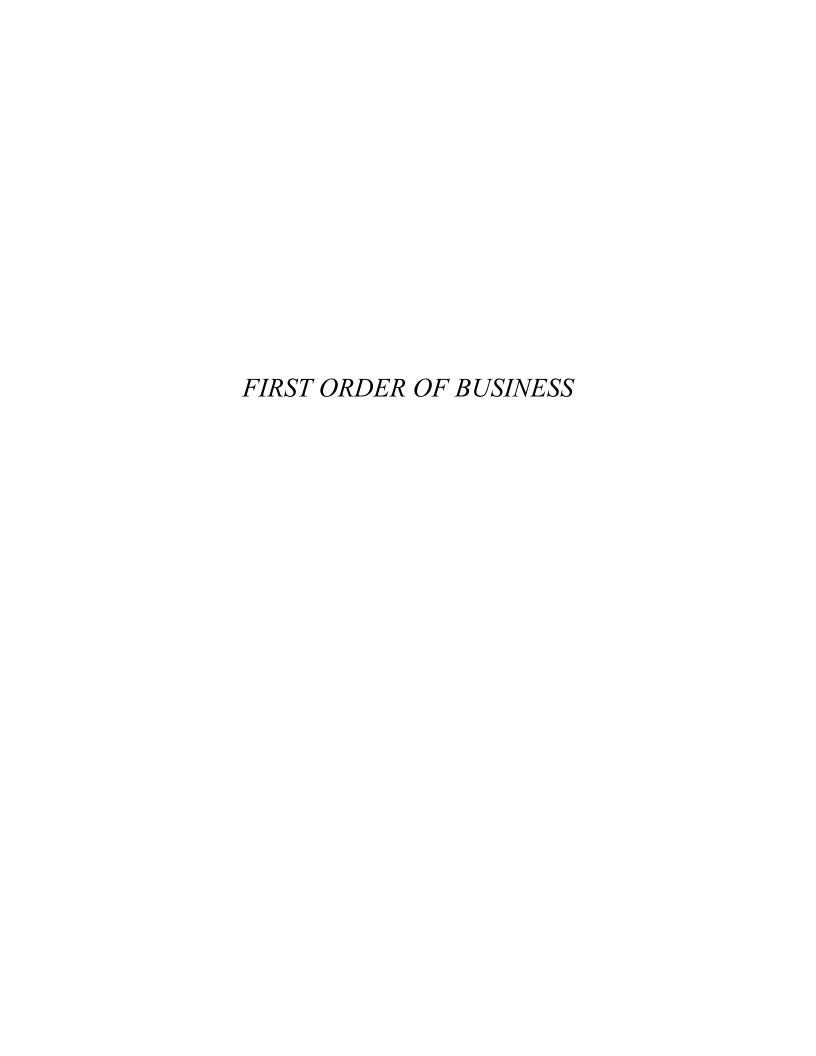

Everything looks status quo on the balance sheet and it looks like we will be able to do the standard number distribution of \$840,000 as budgeted for 2023.

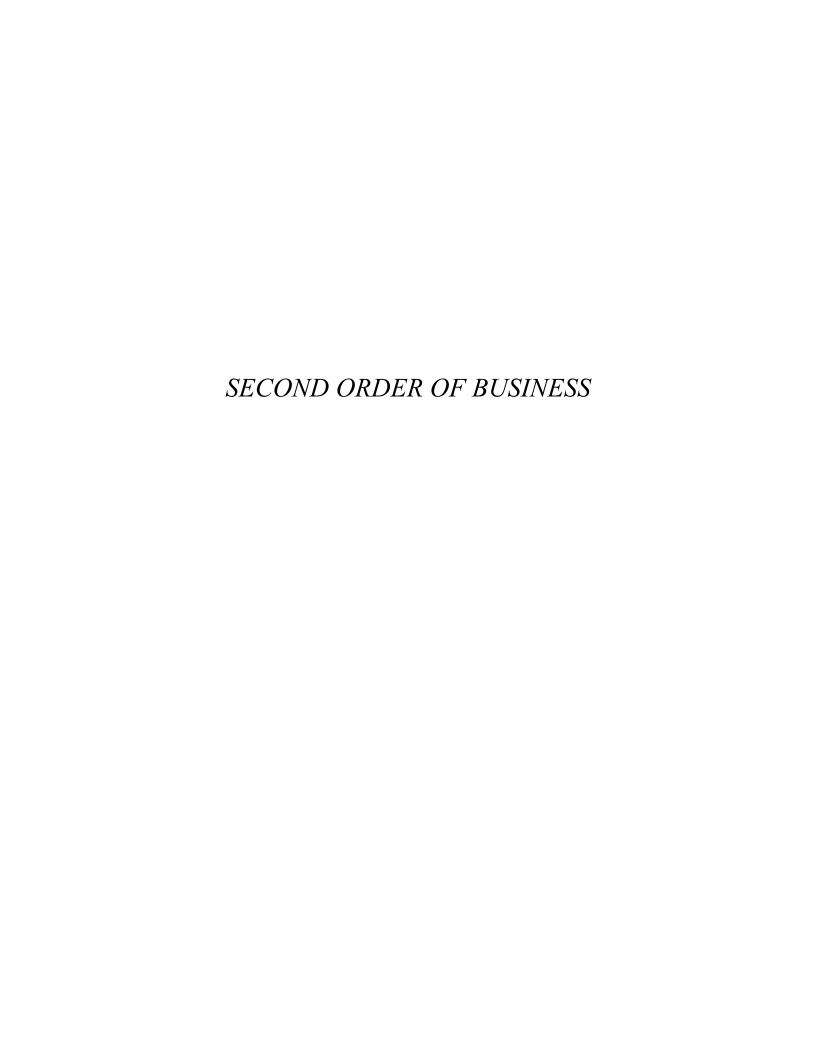
