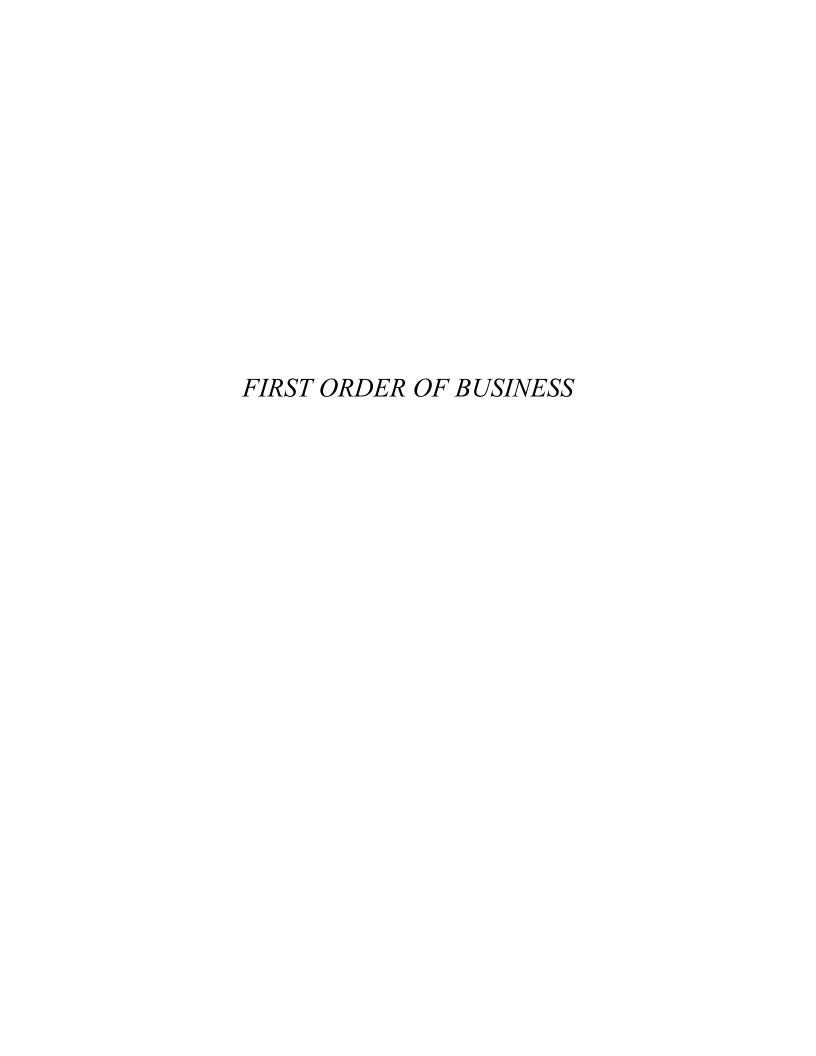

II. Review and Consideration of Action on the Agreement with AECOM for the TIFA Area IV Wellfield Operational Resiliency Study

Mr. DeMayo: The city attorney had two items: the city doesn't need the indemnification and he is not reviewing the form of the contract and there is a signature spot for him that will have to be removed. AECOM has this with their legal staff and have not gotten back to us, we would like you to allow staff and the parties to work with AECOM to come to a resolution on contract terms.

Ms. Hutchins: Jim Boyd and I have been working on it and are comfortable as to the form and content. As long as everyone else can come to agreement we made sure all the pertinent property access and insurance requirements are in place.

Member Ball moved to approve in substantial form and authorized staff to make changes as needed and to circulate for signatures. Member Lee concurred and the motion passed.

Mr. Sanford gave a presentation on the regulated program through Florida Power & Light, that allows FP&L to design, procure, install and own and maintain backup power equipment on a customer's premises, and to place the cost on the bill over the course of 20 years, then reviewed the proposal for TIFA that would be \$18,059 monthly fixed cost for 20 years per generator 10-12 month delivery.

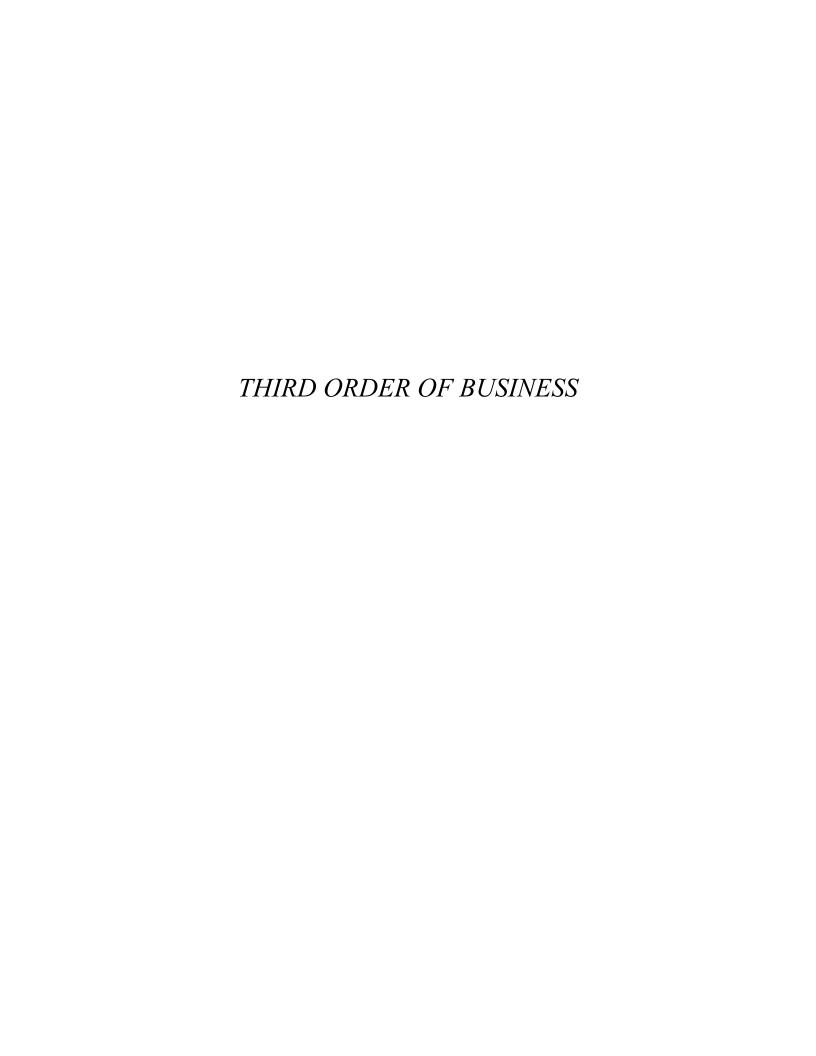
